School Parental Involvement Policy

PART I. GENERAL EXPECTATIONS

NOTE: There is no required format for written expectations; this is a sample of what might be included.

The Schneckenburger agrees to implement the following statutory requirements:

4. The **Schneckenburger** will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
 - Monthly newsletters
 - Open House
 - Student report cards/ Interim reports
 - ESL support staff
 - Pre-K and K parent meetings
 - Social Worker

5. The **Schneckenburger** will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - Inviting parents to SIDT meetings.
 - Responding to parents requests for volunteering
 - Responding to parents requests for conferences
 - Student report cards/ Interim reports
 - LANA, Faculty Needs Assessment and Parental Involvement evaluations

6. The **Schneckenburger** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
 - Sending home State assessment scores in a timely manner.

7. The **Schneckenburger** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
 - Notification of highly qualified status by letter.

8. The **Schneckenburger** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators:By:
 - Guidance on state website.
 - Parent conferences
 - Informational pamphlets provided by the state to be sent home
 - Social Worker
 - Math and Literacy Night
 - IEPs (Individual education plans)
 - Instructional home learning with take home materials for Pre-K parents
 - Events for parents and their children held by Kid's Hope Mentoring Program

9. The **Schneckenburger** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
 - Guidance on state website.
 - Parent conferences
 - Informational pamphlets provided by the state to be sent home
 - Scholastic Book Fairs
 - Individual Education Plans (IEPs)

10. The **Schneckenburger** will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
 - Eliciting parent involvement through monthly newsletters.
 - Distributing parent involvement newsletters provided by district and state.
 - School Improvement Team meetings
 - DARE program

- Partnerships with Walmart, Sam's, Kids Hope Mentoring Program, United Way, Kiwanis
- K-Kids
- Parent-teacher conferences

11. The **Schneckenburger** will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

- Inviting Head Start parents and children to visit our site each year.
- Pre-K parent meetings

12.
